EC.15-13.1	EPC Policy Update - Deletion or Relocation of College Programs
	The EPC committee met on March 26, 2015. Revised the deletion or relocation policy which is now titled "Suspension or Relocation of college programs". The section "procedures" was removed from the policy and a separate procedures guideline was created. Guiding principles were also added to the policy. No further input from clusters was received. The draft needs to go to BOG and legal for review.
	Recommendation for the policy to go back to the EPC committee to discuss adding a timeline around suspending programs. Possibly adding deletion after a period of time.
	<b>Housekeeping:</b> Remove "deletion" from page 3. Add "VP Academic" under administrative responsibility on page 1. Add (1.e) to page 2 right after (1.b).

	No critical feedback received from ABT, BADM, or Nursing clusters.

EC.15-13.3	Nursing Admission Requirements – Kathy Haley
	Proposing changes to nursing admission requirements in college calendar regarding ESL students. Currently, the admission requirements do not speak to ESL students. CNC and UNBC have passed the proposed changes.
	Under the proposed changes, if a student declares that they are ESL, then the student will need to meet the proposed requirements and get 67% in English 12 and write one of the two English language tests. If they do not declare, they may be able to communicate effectively but they run the risk of failing out if they cannot. Support will be offered however, in the past ESL students have had to leave the program because of communication challenges. The NCBNP feels declaring is in the student's best interest and is not meant to provide a barrier to the student.
	Changes to the admission requirements will read as follows:
	"Applicants whose first language is not English, regardless of citizenship or country of origin, must submit evidence of English language proficiency prior to admission. For the NCBNP the

Second proposed change is to align NWCC's admission requirements with UNBC and to create this alignment, NWCC needs to add the grade of "C+" next to the percent grade of 67%.

Suggestion to increase the percentage and letter grade of English language requirement and to make it mandatory for ESL students to meet with a student advisor. Due to UNBC striking earlier this month, Kathy Haley was not able to discuss that with UNBC. It is imperative the CNC/UNBC/NWCC all agree to changes that are submitted to EDCO. Currently, UNBC has 67% as their requirement and NWCC needs to adhere to that.

Finding that parents are unaware that 1st and 2nd year UC is available at our campuses.

Reason that promoting programs/courses is not happening comes down to not knowing whose responsibility it is to promote the programs. It is very hard to coordinate with other departments to make visits out to the community together.

Recommendation to involve communications (or someone) to submit a request for fall recruitment sign up and have clusters go out into the community as a team.

Action Item: Send recommendation from EDCO table to marketing/communications (Sarah Zimmerman) regarding interest in coordinating recruitment strategies. Possibly including Sarah Zimmerman and Holly Hovland, instructors, and other volunteers (student reps/student ambassador) to go together to the high schools and do a formal event. Recommendation for Holly Hovland to put word out for students to volunteer for trade show.
